## DIRECTIONS TO SHOW GROUNDS

FROM THE NORTH: Take I-91 to West Springfield-Exit 13B. Follow Route 5 South to Route 147 West (Memorial Ave) for about 1 mile. Enter Show Grounds thru Gate 9 on the left prior to reaching the Grounds proper.

FROM THE SOUTH: Take I-91 North to Springfield-Exit 3. Follow Route 5 North to Route 147 West (Memorial Ave), then proceed as above.

FROM THE EAST OR WEST: Take Mass Pike (I-90) to exit 4. Follow Route 5 South to Route 147 West (Memorial Ave), then proceed as above.

FROM BRADLEY INT'L AIRPORT: Take Route 75 North to Route 147 East for about 12 miles to Gate 9 on the right.
